SHOULD A SCHOOL WITHDRAW FROM A SECTION 2 TOURNAMENT WITHIN 48 HOURS OF AN UNSEEDDED TOURNAMENT OR AFTER THE SEEDING MEETING IN A SEEDDED TOURNAMENT (UNLESS EXTENUATING CIRCUMSTANCES CAN BE DEMONSTRATED, SUCH AS: TEAM TRAINING RULE VIOLATIONS, TEAM ILLNESS, ACT OF GOD OR OTHER EMERGENCY) THE SCHOOL INVOLVED WILL BE FINED \$250.00, PAYABLE TO SECTION 2, FOR THE FIRST OFFENSE. FOR A SECOND OFFENSE (OR FAILURE TO PAY THE FINE), A SCHOOL WILL BE INELIGIBLE TO PARTICIPATE IN THE SECTIONALS IN THE SPORT IN QUESTION FOR THE FOLLOWING YEAR.
